## THE SPECIAL COURT FOR SIERRA LEONE ("the Special Court")

SITTING as the Trial Chamber (hereinafter "the Chamber"), composed of Judge Bankole Thompson, Presiding Judge, Judge Pierre Boutet and Judge Benjamin Mutanga Itoe;

**CONSIDERING** the Prosecution Request for Appearance before the Trial Chamber to Withdraw an Indictment, pursuant to Rule 51(B) filed on the 14<sup>th</sup> day of November 2003 (hereinafter "the Request");

**CONSIDERING** the Indictment against SAM BOCKARIE aka MOSQUITO aka MASKITA, for Crimes against Humanity, Violations of Article 3 Common to the Geneva Conventions and of Additional Protocol II and Other Serious Violations of International Humanitarian Law, in violation of Articles 2, 3 and 4 of the Statute of the Special Court for Sierra Leone issued on the 3<sup>rd</sup> day of March 2003;

**CONSIDERING** the Decision Approving the Indictment and Order for Non-Disclosure of the 7<sup>th</sup> day of March 2003;

**CONSIDERING** the certified copy of the Death Certificate issued for Sam Bockarie alias Mosquito "Maskita" of the 2<sup>nd</sup> day of June 2003;

CONSIDERING Rule 51(B) of the Rules of Procedure and Evidence for the Special Court for Sierra Leone;

**CONSIDERING ALSO** the appearance of the Prosecutor before the Trial Chamber on the 5<sup>th</sup> day of December 2003;

**NOTING** the statement of reasons presented by the Prosecutor to the Trial Chamber on the 5<sup>th</sup> day of December 2003, in which the Prosecutor submitted that the evidence available has indicated to his satisfaction that Sam Bockarie is deceased;

## NOW THEREFORE,

THE CHAMBER ACCEPTS the Prosecutor's statement of reasons;

and ENDORSES the withdrawal of the Indictment.
