THE SPECIAL COURT FOR SIERRA LEONE ("the Special Court"),

SITTING AS Judge Bankole Thompson, Presiding Judge and Judge designated pursuant to Rule 28 of the Rules of Procedure and Evidence ("the Rules");

HAVING RECEIVED on the 24th June 2003 from the Registrar pursuant to Rule 47 (D) of the Rules the enclosed indictment and accompanying material against ALLIEU KONDEWA also known as KING DR. ALLIEU KONDEWA also known as DR. ALLIEU KONDEWA, a citizen of Sierra Leone born in Bo district in the Southern Province of the Republic of Sierra Leone, hereby accused of Crimes Against Humanity, Violations of Article 3 Common to the Geneva Convention and Additional Protocol II, and Other Serious Violations of International Humanitarian Law;

CONSIDERING that ALLIEU KONDEWA was transferred to the Special Court Detention Facility on the 29th May 2003 and currently remains in the custody of the Special Court pursuant to Rule 40 bis of the Rules:

CONSIDERING the requirements under Rule 47 (E) of the Rules;

BEING SATISFIED from the material tendered by the Prosecutor that the indictment charges the suspect with crimes within the jurisdiction of the Special Court, and that the allegations in the Prosecutor's case summary would, if proven, amount to crimes as specified and particularised in the indictment;

HEREBY APPROVES, pursuant to Rule 47 of the Rules, the Indictment submitted by the Prosecutor against the Accused in respect to each and every of the eight (8) counts;

CONSIDERING ALSO the Prosecutor's request that an Order for the Continued Detention of the aforesaid ALLIEU KONDEWA be issued by the Special Court against the said ALLIEU KONDEWA;

CONSIDERING ARTICLE 17 (2) of the Agreement between the United Nations and the Government of Sierra Leone on the Establishment of the Special Court for Sierra Leone;

CONSIDERING ALSO the Special Court Agreement 2002 (Ratification) Act 2002, section 20, which states that an Order of the Special Court shall have the same force or effect as if it had been issued by a Judge, Magistrate, Justice of the Peace of a Sierra Leone Court;

GRANTS the Prosecutor's request for the continued detention of the said ALLIEU KONDEWA in the custody of the Special Court;

HEREBY DIRECTS the Registrar, pursuant to Rule 52 and 55 (B) of the Rules, to serve on the Accused and on the Government of Sierra Leone the following documents:

- 1. The Decision herein of the Special Court Approving the Indictment;
- 2. The Approved Indictment;
- 3. The Order herein for the Continued Detention in the Custody of the Special Court of the said **ALLIEU KONDEWA**
